For 48 years, The Justice Education Center has been committed to helping children, youth, families and strengthening our communities. Our programs are far-reaching and include girls and boys sports, health and wellness; preapprenticeship trainings to prepare youth and young adults for technology careers; year-round and summer prevention programs in sports, arts, and nutrition that are designed to encourage teamwork, build confidence and self-esteem; preparatory programs for high school juniors and seniors to help them successfully transition to college or the workforce, and second chance programs for people returning to our communities.

(Our newest 30-week program launched in January — Project MOO — is introducing 8-14 year-olds to farm life and the caring for animals.)
